**REQUEST FOR DRIVERS SAFETY COURSE**

### HOW TO REQUEST A DRIVING SAFETY COURSE

You may be eligible to attend a driving safety course for dismissal of your ticket. You can only take a driving safety course for ONE violation.

**You are eligible for a Driving Safety Course if:**

- 1) You did not possess a Commercial Driver's License at the time of the offense.
- 2) You have not completed a Driving Safety Course for ticket dismissal in the previous 12 months (calculated from date of previous completion to the violation date of your current citation).
- 3) You have a valid Texas driver's license or permit.
- 4) You have valid proof of insurance showing you as a covered driver.
- 5) Your violation was not in a construction/work zone with workers present.
- 6) Your citation was for a moving violation.
- 7) If cited for speeding, your actual speed must be less than 25 mph over the speed limit, or less than 95 mph.
- 8) You may NOT be eligible for a driving safety course for the following moving violations: Speeding: 25 MPH over limit, traffic-related offenses involving a school bus or passing an emergency vehicle. You may request a driving safety course for only ONE moving violation.

**If you are eligible, you may sign up for a Driving Safety Course by sending the following 5 items to the Court or appearing at the Court on or before your appearance date:**

- 1) Required fees: \$129.00 for Non-School Zone Violations and \$154.00 for School Zone Violations
- 2) A copy of your valid Texas Driver's license.
- 3) A copy of your valid insurance showing you as a covered driver.
- 4) The Driving Safety Course request form below (completed).
- 5) The Driving Safety Course Affidavit form below (completed)
